## 360 Capital Digital Infrastructure Fund (TDI) Managed Investment Trust Notice for Custodians and other Intermediary Investors in 360 Capital Digital Infrastructure Fund

360 Capital FM Limited as Responsible Entity of the 360 Capital Digital Infrastructure Fund (360CDIF) (ARSN: 635 566 531) considers the trust is a managed investment trust for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 and applies the Attribution Managed Investment Trust (AMIT) regime in respect of the income year ending 30 June 2020.

The AMIT information presented below is relevant for non-resident investors and custodians of non-resident investors that are obliged to deduct withholding tax (WHT) on payments made to non-resident investors.

For the purposes of section 12-415 of Schedule 1 of the Taxation Administration Act 1953, this distribution includes a "fund payment" of 4.7707 cents per security in respect of the income year ending 30 June 2020.
