**Managed Investment Trust Notice for Custodians and other Intermediary Investors in  
360 Capital Mortgage REIT**

360 Capital FM Limited as responsible entity of the 360 Capital Mortgage REIT (**TCF** or **Trust**) considers the Trust is a withholding managed investment trust for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 and applies the Attribution Managed Investment Trust (**AMIT**) regime in respect of the financial year ending 30 June 2026.

Set out below are the estimated taxable components of the **January 2026 monthly distribution of 5.0 cents per unit** to be paid on or about 6 February 2026. These components are provided solely for the purposes of MIT non-resident withholding tax under Subdivision 12-H and 12A-B of Schedule 1 of the Taxation Administration Act 1953, and non-resident interest withholding tax under Subdivision 12-F of Schedule 1 of the Taxation Administration Act 1953 and should not be used for any other purpose.

The components are **estimates only** - the actual components for the income year ending 30 June 2026 will be advised in August 2026.

The fund payment is **nil** cents per unit in respect of the January 2026 monthly distribution.

The fund payment has been determined in accordance with Subdivision 12A-B of Schedule 1 to the Taxation Administration Act 1953, being the amount from which an amount would have been required to be withheld under Subdivision 12-H of Schedule 1 to the Taxation Administration Act 1953 if the payment had been made to an entity covered by section 12-410 of that Schedule.

**Australian resident Unitholders should not rely on this notice for the purposes of completing their income tax returns.** Details of the full year components of distributions will be provided in the AMIT Member Annual (AMMA) Statement, which will be sent to Unitholders in August 2026.
